- (1) "EVRDRL" and U.S. Registration No. 5623370 (Registration Date: December 4, 2018); and
- (2) "ARROGATE DEFENDER" and U.S. Registration No. 5623382 (Registration Date: December 4, 2018).

ASSIGNMENT

Subject to the terms and conditions of this Assignment, Assignor hereby irrevocably assigns, conveys, sells, grants and transfers and agrees to assign, convey, sell, grant and transfer to Assignee, and its successors and assigns, all of its rights, title and interest of every kind and character throughout the world, including moral rights, in and to the Marks to the full extent of its ownership or interest therein, whatever that may be; including, without limitation, all federal, state, foreign, statutory and common law and other rights; all domestic and foreign trademark applications and registrations therefor (and all extensions and renewals of such applications and registrations, and the right to apply for any of the foregoing); all goodwill associated therewith symbolized by the Marks and the portion of the business of the Assignor to which the Marks

Upon Assignee's request, Assignor will promptly take such other actions, including, without limitation, the prompt execution and delivery of documents in recordable form, as may be reasonably necessary to vest, secure, perfect, protect or enforce the rights and interests of Assignee in and to the Marks.



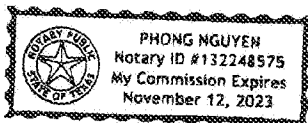
