**TRADEMARK RELEASE AND REASSIGNMENT**

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of June 6, 2022, by BANK OF AMERICA N.A., as Agent (in such capacity, "Agent") in favor of TPC Group LLC, a Texas limited liability company ("Grantor").

WITNESSETH:

WHEREAS, Agent and Grantor are parties to that certain Grant of Security Interest in United States Trademarks, dated as of August 2, 2019 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "Agreement"; all capitalized terms used herein but not otherwise defined herein shall have the respective meanings ascribed to such terms in the Agreement), pursuant to which Grantor granted a security interest to Agent in the Trademarks, including the Trademarks set forth on Schedule 1 hereto, together with all Proceeds therefrom (collectively, the "Trademark Collateral"); and

WHEREAS, the Agreement was recorded by the United States Patent and Trademark Office ("USPTO") on August 2, 2019 at Reel 6711, Frame 0270;

WHEREAS, Grantor has requested that Agent release its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral and reassign the same to Grantor; and

WHEREAS, Agent has agreed to release the entirety of its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby terminates the Agreement and releases its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral, including the Trademarks referred to on Schedule 1.


