TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "Agreement") is between Magic One, LLC, a North Carolina limited liability company ("Assignor") and Dent Wizard International Corporation, LLC, a Delaware limited liability company ("Assignee").
