INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This Intellectual Property Assignment Agreement (“**Assignment**”) is hereby entered into on October 14, 2021, by and among Gaea Mobile Limited, a Hong Kong company (“**Gaea Mobile**”), Gaea Hong Kong Holdings Limited, a Hong Kong company (“**Gaea Holdings**”), Beijing Gaea Interactive Entertainment Co., Ltd. (北京盖娅互娱网络科技股份有限公司), a company organized under the laws of the People’s Republic of China (“**Gaea Beijing**”), GAEA Mobile (US) Corporation, a California corporation (“**Gaea US**” and, together with Gaea Mobile, Gaea Holdings and Gaea Beijing, each an “**Assignor**” and collectively, the “**Assignors**”), and Deca Games EOOD, a Bulgarian company (“**Assignee**”).

WHEREAS, each Assignor is the sole and lawful owner of the entire right, title and interest in and to the Intellectual Property shown on Schedule 1 of this Assignment (the “**Assigned IP**”), and that the same are unencumbered, and that such Assignor has good and full right and lawful authority to sell and convey the same in the manner herein set forth;

WHEREAS, each Assignor agrees to sell, transfer, convey, assign and deliver to Assignee all of such Assignor’s rights, title and interest in and to the Assigned IP; and

WHEREAS, Assignee desires to acquire from the Assignors all rights, title and interest in and to the Assigned IP;

NOW, THEREFORE, in consideration of good and valuable considerations by Assignee, the receipt and sufficiency of which are hereby acknowledged, each Assignor shall and hereby does irrevocably assign, convey, transfer and deliver unto Assignee all of such Assignor’s full, exclusive and entire right, title, and interest in and to the following Intellectual Property:

1. the trademark registrations and applications set forth on Schedule 1 hereto, together with the goodwill connected with the use thereof and symbolized thereby, and all issuances, extensions, and renewals thereof (collectively, the “**Trademarks**”); and
2. the copyright registrations and applications set forth on Schedule 1 hereto, together with the goodwill connected with the use thereof and symbolized thereby, and all issuances, extensions and renewals thereof (collectively, the “**Copyrights**”).

For the same consideration, each Assignor hereby agrees to execute and deliver to Assignee any further documents and instruments in such Assignor’s possession, and to do any and all further reasonable acts that are deemed necessary by Assignee to vest in Assignee all right, title, and interest in and to the Assigned IP and to enable such right, title, and interest to be recorded in the PTO any other appropriate governmental or private authority, agency or registry of the United States and internationally. Assignor agrees to designate Assignee as Assignor's successor in interest and have the same rights as Assignor as if this Agreement had not been made.

For the same consideration, each Assignor agrees, without charge to Assignee, but at Assignee’s expense, to sign all lawful papers, execute said application, related US applications and related foreign applications, make all assignments and rightful oaths, assist in prosecution


of said application, related US applications and related foreign applications, assist in prosecution of legal proceedings, and generally do everything reasonably possible to aid Assignee its successors, assigns, and nominees, to obtain and enforce proper protection for all said inventions and improvements in all countries throughout the world.

AND, for the same consideration, each Assignor also hereby sells, assigns and transfers unto Assignee all rights and claims to sue and recover for damages and other remedies (including equitable remedies) with respect to any and all past infringement, misappropriation or violation of all said Intellectual Property, including any related applications, related US applications, and related foreign applications, including said inventions and improvements which may have occurred before the date of this Assignment.



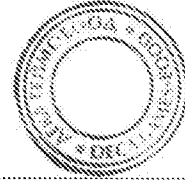


