**ARTICLES OF CONVERSION**  
**OF**  
**PEACE COFFEE, LLC**  
a Minnesota limited liability company  
(the "Converting Limited Liability Company")  
**INTO**  
**PEACE COFFEE PBC,**  
a Delaware public benefit corporation  
(the "Converted Organization")

Pursuant to the provisions of Minnesota Statutes, Chapter 322C, the undersigned Converting Limited Liability Company executes the following Articles of Conversion:

1. The name of the Converting Limited Liability Company before the Conversion is Peace Coffee, LLC, a Minnesota limited liability company. The Converting Limited Liability is converting into a Delaware public benefit corporation (the "Conversion").

2. The name of the Converted Organization after the Conversion shall be Peace Coffee PBC, a Delaware public benefit corporation, which name satisfies the laws applicable to the Converted Organization.

3. The conversion is effective under the governing statute of the Converted Organization upon filing of the Certificate of Conversion and Certificate of Incorporation with the Delaware Secretary of State.

4. The conversion has been approved as required by the Converting Limited Liability Company in accordance with Minnesota Statutes, Chapter 322C.

5. The conversion was approved as required by the governing statute of the Converted Organization.



The Converted Organization consents to the jurisdiction of the courts of the State of Minnesota to enforce any debt, obligation, or other liability for which the Converting Limited Liability Company is liable if, before the conversion, the Converting Limited Liability Company was subject to suit in the State of Minnesota on the debt, obligation, or other liability.

7. The Converted Organization irrevocably appoints the Secretary of State of the State of Minnesota as its agent for service of process. The address to which the Secretary of State may forward any process is: 2801 21<sup>st</sup> Ave S, Suite #130, Minneapolis, MN 55407.
