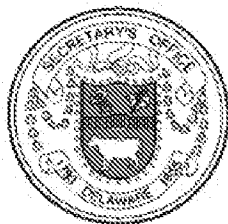

On January 17, 2017, the Other Entity filed a Certificate of Conversion From a Delaware Limited Liability Company to a Non-Delaware Entity with the Secretary of State of the State of Delaware and converted to a Utah limited liability company with the name Bridge Investment Group LLC.
