## **Release Of Trademark Collateral Agreement**

This Release of Trademark Collateral Agreement (this "Release") is made as of June 10, 2022, by BMO HARRIS Bank N.A., a national banking association, with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603, and its successors and assigns ("Secured Party"), in favor of PPT Industrial Machines Inc., an Illinois corporation, with its principal place of business at 714 North Walnut Street, Mt. Carmel, Illinois 62863 ("Debtor").

WHEREAS, pursuant to the terms and conditions of that certain Trademark Collateral Agreement dated August 6, 2015, between Debtor and Secured Party (the "Security Agreement"), Debtor granted to Secured Party a security interest in and to Debtor's right, title and interest in, to and under certain of Debtor's trademarks, and proceeds related thereto, and all other collateral identified in the Security Agreement, including those set forth on Schedule A attached hereto ("Trademarks");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on August 11, 2015 at Reel 5597, Frame 0871; and

WHEREAS, Debtor and Secured Party have agreed that the security interest, memorialized by the Security Agreement, in and to the Trademarks shall be terminated.


