ARTICLES OF AMENDMENT

Pursuant to §55-10-06 of the General Statutes of North Carolina, the undersigned corporation hereby submits the following Articles of Amendment for the purpose of amending its Articles of Incorporation.

1. The name of the corporation is RFPi, Inc.
2. The Articles of Incorporation of the corporation are hereby amended by deleting Article I in its entirety and substituting the following Article I in lieu thereof:
