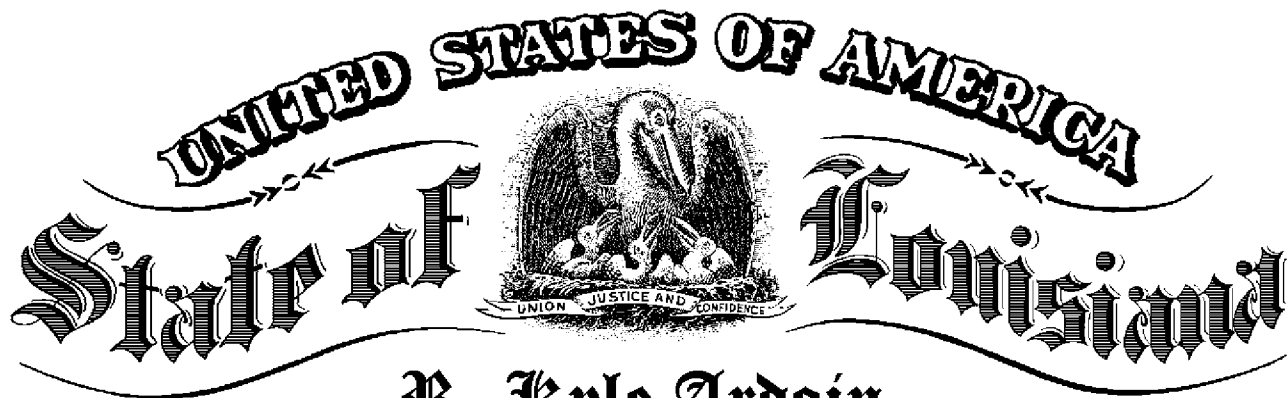

**ARTICLES OF ENTITY CONVERSION**

**CONVERTING**

(A LOUISIANA CORPORATION)**

**CASH MONEY RECORDS, LLC  
(A LOUISIANA LIMITED LIABILITY COMPANY)**

Cash Money Records, Inc. (the "Converting Entity"), acting pursuant to §§ 12:1-950 *et seq.* of the Louisiana Business Corporation Act, and for the purpose of converting the Converting Entity to a Louisiana limited liability company (the "Converted Entity"), hereby adopts these Articles of Entity Conversion and hereby declares and certifies as follows:

**ARTICLE 1  
NAME OF ENTITIES**

The name of the Converting Entity is Cash Money Records, Inc. The name of the Converted Entity is Cash Money Records, LLC.

**ARTICLE 2  
TYPE OF RESULTING CONVERTED ENTITY**

Cash Money Records, LLC, the Converted Entity, is a Louisiana limited liability company.

**ARTICLE 3  
STATEMENT OF CONTINUING EXISTENCE**

The Converting Entity is continuing its existence, without interruption, in the form of the Converted Entity, Cash Money Records, LLC. The conversion effected by these Articles of Entity Conversion will not constitute a dissolution of the Converting Entity, and the Converting Entity will not be required to wind up its affairs or pay its liabilities and distribute its assets by virtue of, or as a result of, this conversion.

**ARTICLE 4  
CONVERSION OF OWNERSHIP INTERESTS**

All issued and outstanding shares of common stock of the Converting Entity on the effective date of the conversion shall be converted on a pro rata basis into 100% of the membership interests of the Converted Entity. Such membership interests in the Converted Entity shall be expressed in membership units totaling one thousand (1,000) authorized membership units on the effective date of the conversion.

**ARTICLE 5  
SHAREHOLDER APPROVAL**

The Plan of Entity Conversion has been duly approved by the board of directors and the shareholders (with all votes in favor and zero against) of the Converting Entity, in accordance with La. R.S. 12:1-953 and the Articles of Incorporation.

**ARTICLE 6  
ARTICLES OF ORGANIZATION  
OF CASH MONEY RECORDS, LLC**

The following constitutes the Articles of Organization of the Converted Entity:

**ARTICLES OF ORGANIZATION  
OF  
CASH MONEY RECORDS, LLC**

The undersigned organizer, in the presence of the undersigned witnesses and Notary Public adopts the following Articles of Organization.

**ARTICLE I  
NAME**

The name of the limited liability company is CASH MONEY RECORDS, LLC (the "Company").

**ARTICLE II  
DURATION**

The duration of the Company is perpetual.

**ARTICLE III  
PURPOSE**

The purpose for which the Company is organized is to transact any and all lawful business for which limited liability companies may be organized under the Louisiana Limited Liability Company Law.

**ARTICLE IV  
LOW-PROFIT**

The Company is not a low-profit limited liability company.

**ARTICLE V  
MANAGEMENT**

This Company shall be managed by the members, as provided in the Operating Agreement of the Company. The rights and duties of the members will be specified in the Operating Agreement of the Company.

**ARTICLE VI  
AUTHORITY**

Any member of the Company is authorized to execute certificates establishing the membership of any member, the authenticity of any records of the limited liability company or the authority of any person to act on behalf of the Company, including but not limited to, providing a statement of those persons or entities with the authority to take the actions referred to in La. R.S. 12:1318(B). No person dealing with any such member of the Company will be required to determine his authority to provide such certifications on behalf of the Company, or to determine any fact or circumstances bearing upon the existence of his authority and shall be entitled to conclusively rely upon such certificates.

**ARTICLE VII  
LIMITED LIABILITY**

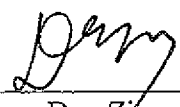
No member of the Company shall be personally liable for monetary damages for breach of any duty provided for in La. R.S. 12:1314.


If, after the effective date of this Article VII, the Louisiana Limited Liability Company Law is amended to authorize company action further eliminating or limiting the personal liability of the members, then the liability of the members of the Company shall be eliminated or limited to the fullest extent permitted by the Louisiana Limited Liability Company Law, as so amended.

Any repeal or modification of this Article VII by the members of the Company shall not adversely affect any right or protection of the members of the Company under this Article VII with respect to any act or omission occurring prior to the time of such repeal or modification.

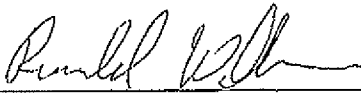

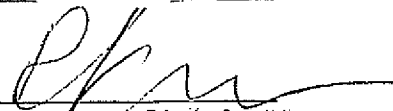

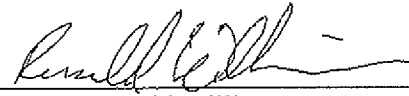
