**CONVERSION APPLICATION FOR

Pursuant to Louisiana Revised Statutes 12:1601, et seq., Shaw Intellectual Property Holdings, Inc., a Louisiana corporation, hereby executes the following application for conversion into a Louisiana limited liability company:

1. (a) The name of the converting entity is Shaw Intellectual Property Holdings, Inc.  
(b) The name of the converted entity is Shaw Intellectual Property Holdings, LLC.
2. The converted entity is a limited liability company.
3. The converting entity is continuing its existence in the organizational form of a limited liability company.
4. The outstanding shares of the converting entity shall be converted automatically upon the effectiveness of this application into membership interests of the converted entity on an equal basis, such that the sole shareholder in the converting entity will be the sole owner of the membership interests in the converted entity.

R.S. 12:1318(B). No person dealing with a member of the company shall be required to determine such member's authority to make any such commitment or undertaking on behalf of the company or to determine any fact or circumstance

bearing upon the existence of such member's authority and shall be entitled to conclusively rely upon such certificates.

- e. No Personal Liability. No member of the company shall be personally liable or bear any responsibility whatsoever for any of the debts, obligations, or liabilities of the company.

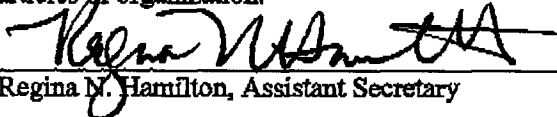
