TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT ("Assignment") is made and entered into, effective as of June 14, 2022, by and between Sweeping Corporation of America, LLC, a Tennessee limited liability company with a principal address of 4141 Rockside Road, Suite 210, Seven Hills, Ohio 44131 ("Assignor"), and Sweep America Intermediate Holdings, LLC, a Delaware limited liability company with a principal address at 4141 Rockside Road, Suite 210, Seven Hills, Ohio ("Assignee", together with Assignor, "the Parties").

WHEREAS, Assignor owns the trademark, the goodwill of the business associated therewith and symbolized thereby, and the U.S. Trademark Registration therefor, as depicted on Exhibit A attached hereto and incorporated herein by reference (the "Trademark");

WHEREAS, Assignor desires to contribute, transfer, and assign all right, title, and interest in and to the Trademark, the goodwill of the business associated therewith and symbolized thereby, and the U.S. Trademark Registration therefor, to Assignee, and Assignee desires to receive the same;

NOW THEREFORE, in consideration of the mutual covenants and promises of the Parties, and in exchange for good and valuable consideration the receipt and sufficiency of which the Parties hereby acknowledge, the Parties agree as follows:

1. Assignor hereby contributes, transfers, and assigns to Assignee: (i) all right, title, and interest in and to the Trademark, together with the goodwill of the business symbolized by the Trademark, associated with the Trademark, and in connection with which the Trademark is used; and (ii) the U.S. Registration for the Trademark as set forth on Exhibit A, and all extensions and renewals thereof; and (iii) all rights, interests, claims, remedies, demands, and damages, recoverable in law or in equity, that Assignor has or may have for past, ongoing, current, and/or future infringements of or other violations of rights in the Trademark, including without limitation the rights to compromise and/or to sue for and/or collect said damages.

2. All of the foregoing shall be held and enjoyed by Assignee, for its own benefit and for the benefit of its successors, assigns, and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor had this Assignment not been made.

3. Assignor agrees to cooperate with Assignee in the recordal of this Assignment with the U.S. Patent & Trademark Office, and to execute any and all documents that are necessary to accomplish such recordal.
