**TERMINATION AND RELEASE OF SECURITY INTEREST IN  
INTELLECTUAL PROPERTY**

**THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, (“Release”) dated as of June 14, 2022, is made by **WEBSTER BANK, NATIONAL ASSOCIATION**, a national banking association, formerly known as Sterling National Bank, in its capacity as administrative agent for the Lenders (as defined below) (together with its successors and assigns in such capacity, “Agent”), under that certain Confirmatory Grant of Security Interest in Intellectual Property, dated as of September 2, 2020, by **BAMBOO ROSE LLC**, a Delaware limited liability company (“Borrower”), in favor of Agent (as amended, restated, supplemented or modified and in effect from time to time, the “IP Security Agreement”). Capitalized terms used but not defined herein shall have the meanings set forth in the IP Security Agreement.

**WHEREAS**, pursuant to the IP Security Agreement, Borrower granted a security interest to Agent (for benefit of the Lenders) in certain intellectual property collateral including the intellectual property set forth on Exhibit A, Exhibit B, and Exhibit C attached thereto (the “IP Collateral”); and


**WHEREAS**, Agent has agreed to terminate and release its security interest in all of such IP Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt of which is hereby acknowledged, Agent does hereby (for itself and for the Borrower) (a) terminate the liens and security interest created under the IP Security Agreement in the IP Collateral, (b) release its security interest in the IP Collateral, and (c) discharge any and all rights, title and interest it has in and the security interest granted to Agent in the IP Collateral. Agent acknowledges that this Release may be filed along with other necessary documentation with the United States Patent and Trademark Office or any other governmental office to evidence the release granted herein.
