**TRADEMARK TRANSFER AGREEMENT**

**THIS TRADEMARK TRANSFER AGREEMENT** (“Assignment”), dated as of this 14th day of June, 2022 (the “Effective Date”) is made and entered into by and between Safelite Group, Inc., (“Safelite”), and Honex Interactive Industries, LLC (“Honex Interactive Industries”).

**WITNESSETH:**

**WHEREAS**, Honex Interactive Industries is a wholly owned subsidiary of Safelite; and

**WHEREAS**, Honex Interactive Industries wishes to assign and transfer to Safelite all of Honex Interactive Industries’ right, title and interest in and to the WINDSHIELD GURU trademark (the “Mark”), including all of Honex Interactive Industries’ rights in U.S. Trademark Reg. No. 4,111,240, together with all of Honex Interactive Industries’ goodwill symbolized by and associated with the Mark, and all of Honex Interactive Industries’ right to sue for past infringement thereof; and

**WHEREAS**, Safelite wishes to acquire all of Honex Interactive Industries’ right, title and interest in and to the Mark, including all of Honex Interactive Industries’ rights in U.S. Trademark Reg. No. 4,111,240, together with all of Honex Interactive Industries’ goodwill symbolized by and associated with the Mark, and all of Honex Interactive Industries’ right to sue for past infringement thereof;

**NOW, THEREFORE**, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto, intending to be legally bound, hereby agree as follows:

**AGREEMENT**

1. **Assignment**. Honex Interactive Industries hereby assigns, transfers, and conveys to Safelite, all of Honex Interactive Industries’ right, title and interest in, to and under the Mark, including all of Assignor’s rights in U.S. Trademark Reg. No. 4,111,240, together with all of Assignor’s goodwill symbolized by and associated therewith, and all of Assignor’s right to sue for past infringement thereof, including, but not limited to, the right to sue and collect damages for any past or future infringements or dilution of the Mark.




