OF GRANTS OF SECURITY INTEREST (TRADEMARKS)**

**TERMINATION AND RELEASE OF GRANTS OF SECURITY INTEREST (TRADEMARKS)** ("Release"), dated as of June 14, 2022, by **JPMORGAN CHASE BANK, N.A.** ("JPMC") (successor by assignment to The Bank of New York ("BNY")), as Administrative Agent (in such capacity, the "Administrative Agent"), in favor of **CURTIS INSTRUMENTS, INC.**, a New York corporation (the "Grantor").

**WHEREAS**, pursuant to the terms of two certain Grants of Security Interest (Trademarks), dated as of 12/16/2005, by the Grantor in favor of the Administrative Agent (the "Agreements"), the Grantor granted to the Administrative Agent a security interest in and to all of the right, title and interest of the Grantor in and to the trademarks listed on Schedule A attached hereto, which trademarks are registered in the United States Patent and Trademark Office (the "Trademarks"), together with the goodwill of the business symbolized by the Trademarks, and all proceeds thereof, including, without limitation, from any and all causes of action which may exist by reason of infringement thereof (the "Collateral"), to secure the prompt payment, performance and observance of the Obligations (as defined in the Security Agreements referred to in the Agreements);

**WHEREAS**, the Agreements were filed on 01/05/2006 with the United States Patent and Trademark Office in Reel 3221/Frame 0570, and on 01/23/2006 in Reel 3232/Frame 0092;

**WHEREAS**, JPMC purchased from BNY a portfolio of loans and all of BNY's right, title and interest in and to all of the collateral securing such loans, including, without limitation, the Collateral;

**WHEREAS**, the Administrative Agent wishes to terminate and release its security interest in and to all of the right, title and interest of the Grantor in and to the Collateral, including the Trademarks identified on Schedule A attached hereto; and

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, releases and discharges fully its security interest in and to all of the right, title and interest of the Grantor in and to the Collateral, including the Trademarks identified on Schedule A attached hereto, and reassigns and transfers to the Grantor all right, title and interest that the Administrative Agent may have in the Collateral, and terminates the Agreements. The Administrative agent hereby authorizes the Grantor, or the Grantor's authorized representative, to record this Release with the United States Patent and Trademark Office.
