**SUPPLEMENT AND JOINDER NO. 1 TO AMENDED AND RESTATED  
TRADEMARK AND PATENT SECURITY AGREEMENT**

This SUPPLEMENT AND JOINDER NO. 1 TO AMENDED AND RESTATED TRADEMARK AND PATENT SECURITY AGREEMENT dated as of May 10, 2022 (“Supplement No. 1”), is made by MOUNT FRANKLIN FOODS, LLC, a Texas limited liability company (“Franklin”), HOSPITALITY MINTS LLC, a Delaware limited liability company (“Hospitality” and together with Franklin, the “Existing Grantors”, and each an “Existing Grantor”), and ELEMENT FOOD SOLUTIONS, LLC, a Delaware limited liability company (“New Grantor” and together with the Existing Grantors, the “Grantors” and each, a “Grantor”), in favor of PNC Bank, National Association, as a lender and as Agent for the Lenders party from time to time to the Second Amended and Restated Revolving Credit, Term Loan, Equipment Loan and Security Agreement (together with its successors and assigns in such capacity, “Agent”) pursuant to that certain Amended and Restated Trademark and Patent Security Agreement, dated as of August 28, 2018, among the Existing Grantors and the Agent, and as recorded with the United States Patent and Trademark Office at Reel 6424 Frame 0880 on August 30, 2018 (as it may be from time to time amended, restated, amended and restated, modified or supplemented, the “Amended and Restated IP Security Agreement”). Capitalized terms used herein and not otherwise defined herein shall have the meanings ascribed thereto in the Amended and Restated IP Security Agreement.

Each Grantor and the Agent, hereby agree as follows:

New Grantor hereby acknowledges, agrees and confirms that, by its execution of this Supplement No. 1, the New Grantor will be deemed to be a “Grantor” for all purposes under the Amended and Restated IP Security Agreement. New Grantor hereby ratifies, as of the date hereof, and agrees to be bound by, all of the terms, provisions and conditions contained in the Amended and Restated IP Security Agreement. New Grantor acknowledges that it has received a copy of the Amended and Restated IP Security Agreement and that it has read and understands the terms thereof.

Each Existing Grantor hereby confirms the grant to the Agent, for the benefit of itself and the Lenders, set forth in the Amended and Restated IP Security Agreement of, and each Existing Grantor and New Grantor do hereby grant to the Agent, for the benefit of itself and the Lenders, a continuing security interest in and Lien upon all of such Grantors’ right, title and interest in and to its respective Collateral, in each case whether now or hereafter existing or in which such Grantors now have or hereafter acquire an interest and wherever the same may be located. Grantors hereby agree that the attached Schedule 1 to this Supplement No. 1 shall constitute part of and an addition to Schedule 1 to the Amended and Restated IP Security Agreement.


