## AFFIDAVIT TO AFFIRM THE RELEASE OF SECURITY AGREEMENT

This Affidavit to Affirm the Release of Security Agreement is effective as of June 14, 2022 pursuant to the fulfillment of the loan obligations.

I, James Housley, do hereby declare as follows:

I am the Chief Financial Officer of Vault.com LLC (f/k/a Vault.com, Inc., a Delaware corporation), a Delaware limited liability company ("Company").

1. Pursuant to the Trademark Security Agreement, dated June 11, 2008 (the "Security Agreement"), Company granted a security interest to CIT Lending Services Corporation (the "Administrative Agent") in the trademark registrations set forth on Schedule A attached hereto (the "Trademarks").
2. The Security Agreement was recorded at the U.S. Patent and Trademark Office (the "USPTO") on July 3, 2008 at Reel/Frame 3809/0031 with respect to the Trademarks.
3. To the best of my knowledge, the obligations secured under the Security Agreement were satisfied. Company repaid all its outstanding loans and other obligations in full, and the Administrative Agent, on behalf of itself and the holders of the Secured Obligations, terminated and released its security interest in the Trademarks.
4. Due to unknown reasons, a release of the Security Agreement was not filed with the USPTO.
