TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT is entered into (hereinafter referred to as the "Agreement") by and between:

Metso Outotec Sweden AB, a Swedish company, under company number 556216-5653 having its registered office at Box 132, 231 22 Trelleborg, Sweden (hereinafter referred to as the "Assignor")

and

Metso Outotec Finland Oy, a Finnish company, under company number 1094259-5 having its registered office at Lokomonkatu 3, 33900 Tampere, Finland (hereinafter referred to as the "Assignee")

(collectively the "Parties")

WHEREAS, the Assignor is the proprietor of the trademarks listed in Schedule 1 hereto (the "Trademarks") and the Assignor wishes to assign and transfer all its rights relating to the Trademarks to the Assignee for the consideration and upon the terms and subject to the conditions set forth in this Agreement.

NOW THEREFORE, the Parties agree as follows:

1. The Assignor hereby assigns and transfers to the Assignee the entire right, title and interest, including goodwill, and the Assignee accepts such assignment and transfer of all right, title and interest, including goodwill, of Assignor in and to the Trademarks. The assignment and transfer shall become effective as of 1 December, 2021.
2. The Parties shall execute any necessary assignments and forms required by governmental agencies to record the transfer of the Trademarks.
3. The Assignee shall pay all documentary, filing, registering and recording fees required in connection with the filing and recording of the assignment described above.
4. As consideration for the transfer of the Trademarks, the Assignee will pay to the Assignor a total amount of € 10 (ten) to a bank account that the Assignor will inform the Assignee about, on a date to be agreed between the Parties.
5. Assignor represents and warrants to the Assignee that:
 - a. it is the sole and exclusive owner of the Trademarks.
 - b. it has the right to assign all rights to the Trademark to the Assignee in accordance with this Agreement and that there is no impediment, such as pledge or otherwise, that prevents the Assignor from assigning the Trademarks to the Assignee in such way that the Assignee will have full, clear and sole title to the Trademarks.
 - c. to the best of its knowledge there is no litigation pending which challenges or otherwise relates to the Assignor's ownership or validity of any or all of the Trademarks.
6. This Agreement shall be governed and construed in accordance with the laws of Finland. All disputes arising out of, or in connection with this Agreement shall be finally settled by

arbitration in accordance with the Arbitration Rules of the Finnish Central Chamber of Commerce by one arbitrator appointed in accordance with said Rules. The arbitration shall take place in Helsinki, Finland. The language to be used in the proceedings shall be English






