TRADEMARK RELEASE AND REASSIGNMENT

This Trademark Release and Reassignment (“Release”) is made as of June 17, 2022, by COMVEST CREDIT PARTNERS V, L.P., as Agent (“Agent”). Capitalized terms used but not defined in this Release shall have the meanings given them in the Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Agent and HOP ENERGY, LLC, a Delaware limited liability company (“Pledgor”) are parties to that certain Trademark Security Agreement (“Agreement”), dated as of September 12, 2019, pursuant to which Pledgor granted a security interest to Agent in certain trademarks of such Pledgor as security for certain obligations owing by Pledgor to Agent;

WHEREAS, the Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on September 12, 2019, at Reel 6743, Frame 0349; and

WHEREAS, Pledgor has requested that Agent release its security interest in the Trademarks and Trademark Collateral and reassign the same to Pledgor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Pledgor’s right, title and interest in and to the following (collectively, the “Trademark Collateral”):

a. all Trademarks of such Pledgor, including, without limitation, the United States registered Trademarks and applications for Trademark registration, listed on Schedule 1 attached hereto, together with any and all (i) right and privileges under Applicable Laws with respect to the use or ownership of any of the foregoing and (ii) continuations, extensions and renewals thereof and amendments thereto;

b. all Goodwill associated with such Trademarks; and

c. all Proceeds of any and all of the foregoing.

2. Agent hereby reassigns, grants and conveys to Pledgor, without any representation, recourse or undertaking by Agent, all of Agent’s right, title and interest in and to the Trademarks and the Trademark Collateral.
