WHEREAS, pursuant to the Security Agreement, Grantor granted to Grantee a security interest in all of Grantor’s right, title and interest in, to and under (i) the copyright registrations (“**Copyrights**”) set forth on Schedule A hereto, (ii) the trademarks, trademark registrations, trademark applications, and any and all goodwill associated therewith (the “**Marks**”) set forth on Schedule B attached hereto, and (iii) the patents and patent applications (the “**Patents**”) set forth on Schedule C attached hereto.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Grantee hereby releases and reassigns to Grantor any and all liens, security interests, right, title and interest of Grantee pursuant to the Security Agreement in, to and under the Copyrights, Marks and Patents, without recourse or representation or warranty, express or implied.


