FIRST: That at a meeting of the Board of Directors of the Corporation resolutions were duly adopted setting forth a proposed amendment of the Fifth Amended and Restated Certificate of Incorporation of the Corporation filed on September 27, 2018, and declaring said amendment to be advisable. The resolution setting forth the proposed amendment is as follows:

RESOLVED, that the Fifth Amended and Restated Certificate of Incorporation of the Corporation be amended by changing the Article thereof numbered "**ARTICLE ONE**" so that, as amended, said Article shall be read as follows:


ARTICLE ONE

The name of the corporation is "Identity Digital Inc." (hereinafter called the "Corporation").
