ASSIGNMENT OF TRADEMARKS

2. WARRANTIES: Assignor represents and warrants:

2.1 Assignor is the owner of the Trademark free and clear of any lien, encumbrance, claim or challenge, the registration is duly perfected, fully paid to date, and in good standing, and the registration is registered without opposition or objection.

2.2 Assignor has not previously assigned its ownership, right, or title, in whole or in part to the Trademarks to any other person.

3. RIGHTS AND OBLIGATIONS:

3.1 Assignor agrees to execute and deliver or cause to be executed and delivered to Assignee for the Trademark or any purchaser of the Trademark from Assignee any and all documents and instruments, in form and substance reasonably satisfactory to Assignee and its counsel, necessary to effect and complete the transfer, grant or sale to Assignee of all rights or property acquired or intended to be acquired by Assignee under this Agreement and shall pay any fees or expense found due and owing prior to the date of

IN WITNESS WHEREOF, each party has agreed that this Assignment of Trademarks shall be effective as of December 21, 2018.


