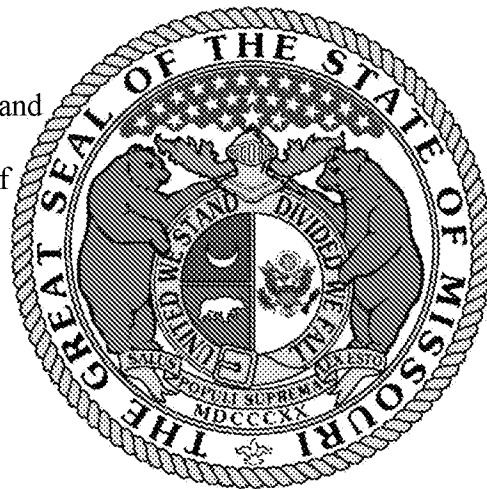

I, the undersigned, for the purpose of converting a corporation into a limited liability company (the "*Conversion*") pursuant to Section 351.409 of the General and Business Corporation Law of the State of Missouri, do hereby execute this Certificate of Conversion and do hereby certify as follows:

ARTICLE I

The name of the corporation immediately prior to filing this Certificate of Conversion is Major Brands, Inc. (the "*Corporation*"), and the name under which the Corporation was originally incorporated was Allstate Distributors, Inc.

ARTICLE II

The date the Corporation's original Articles of Incorporation were filed with the Secretary of State of the State of Missouri is June 13, 1945.

ARTICLE III

The name of the limited liability company into which the Corporation shall be converted is Breakthru Beverage Missouri, LLC. The jurisdiction of the limited liability company into which the Corporation shall be converted is the State of Missouri.

ARTICLE IV

The Conversion of the Corporation into a limited liability company has been approved in accordance with Section 351.409 of the General and Business Corporation Law of the State of Missouri.

ARTICLE V

The Corporation agrees that it may be served with process in the State of Missouri in any action, suit or proceeding for enforcement of any obligation of the Corporation arising while it was a corporation of the State of Missouri, and that it irrevocably appoints the Secretary of State of the State of Missouri as its agent to accept service of process in any such action, suit or proceeding.

### ARTICLE ONE

The name of the limited liability company is **Breakthru Beverage Missouri, LLC**.

### ARTICLE TWO

The limited liability company is formed for the following purposes:

- a) to engage in any lawful business for which a limited liability company may be organized under Sections 347.010 to 347.187 of the Missouri Limited Liability Company Act; and
- b) to exercise all of the powers granted under the provisions of Sections 347.010 to 347.187 of the Missouri Limited Liability Company Act.

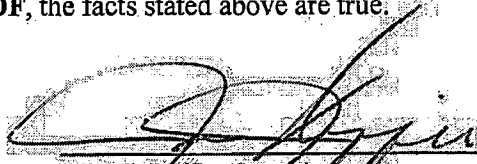
