RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of April 15, 2022 (the “Effective Date”), by **PROSPECT CAPITAL CORPORATION**, as collateral agent (in such capacity, the “Collateral Agent”), in favor of each of the entities listed as grantors on Schedule I attached hereto (each, a “Grantor”, and collectively, the “Grantors”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Guaranty and Security Agreement (as defined below), or if not defined therein, in the Credit Agreement (as defined below).

WHEREAS, reference is made to (a) that certain Amended and Restated Loan Agreement, dated as of June 11, 2020 (as amended, supplemented or otherwise modified, renewed or replaced from time to time, the “Loan Agreement”), among Easy Gardener Products, Inc. (the “Borrower”), Easy Gardener Products Holdings, Inc., Easy Gardener Products Intermediate Holdings, Inc., EZG Holdings, LLC and the other Guarantors referred to therein, the Lenders referred to therein, and the Collateral Agent, and (b) the Guaranty and Security Agreement, dated as of September 30, 2015 (as amended, supplemented or otherwise modified from time to time, the “Guaranty and Security Agreement”), by and among the Borrower, the other parties party thereto, and the Collateral Agent;

WHEREAS, pursuant to the Guaranty and Security Agreement, the Grantors and the Collateral Agent entered into that certain Trademark Security Agreement, dated as of June 24, 2020, which was recorded with the United States Patent and Trademark Office on June 25, 2020 at Reel 006979, Frame 0463 (as amended, supplemented or otherwise modified and in effect from time to time, the “Trademark Security Agreement”);

WHEREAS, pursuant to the terms of the Trademark Security Agreement, each Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, to secure the Secured Obligations, a lien on and continuing security interest in all of such Grantor’s right, title, and interest in, to and under all of its United States Trademarks (as defined in the Guaranty and Security Agreement), including the United States trademark applications and trademark registrations listed on Schedule I attached hereto (collectively, the “Trademark Collateral”); and


WHEREAS, the Collateral Agent now desires to terminate, release and discharge any and all rights, title and interests, including its security interest, in and to the Trademark Collateral granted pursuant to the Trademark Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, releases and discharges any and all rights, title and interests, including its security interest, in and to the Trademark Collateral granted pursuant to the Trademark Security Agreement.
