RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of **June 16, 2022** (“Effective Date”) by and among Wilmington Trust, National Association, a national banking association, solely in its capacity as Notes Collateral Agent (in such capacity, “Grantee”), Builders FirstSource - Intellectual Property, L.P., a Texas limited partnership, Builders FirstSource - Atlantic Group, LLC, a Delaware limited liability company, and ProBuild Holdings LLC a Delaware limited liability company (collectively, “Grantors”).

WHEREAS, pursuant to the terms and conditions of that certain Trademark Security Agreement by and among Grantors and Grantee dated May 30, 2019 (the “Trademark Security Agreement”), Grantors granted to Grantee a Security Interest in the Trademark Collateral, including, without limitation, the United States Trademarks set forth on Schedule A attached hereto;

WHEREAS, Grantors and Grantee entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Notes Collateral Agreement by and among Grantors and Grantee dated May 30, 2019;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) on April 16, 2021, at Reel 006657, Frame 0683;

WHEREAS, Grantors have paid all of their outstanding indebtedness to Grantee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Trademark Security Agreement and hereby terminates, cancels and releases (and reassigns to the Grantors, as applicable) any and all Security Interest in the Trademark Collateral, without recourse, representation or warranty of any kind.

Grantee shall take all further actions, and provide to Grantors, Grantors’ successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantors to more fully and effectively effectuate the purposes of this Release. Grantee hereby authorizes and requests the Commissioner of Trademarks at the PTO record this Release.


