Assignor hereby sells, assigns, transfers and sets over unto Assignee (a) all of Assignor’s rights, title and interest in and to the Trademarks, together with the goodwill associated with the Trademarks, (b) all rights to royalties, fees, income, payments, and other proceeds deriving from the Trademarks, and (c) all claims for damages and other remedies for past and future infringements or misappropriations of the Trademarks, along with the right to sue for and collect such damages and other remedies for the use and benefit of Assignee and its successors, assigns and other legal representatives.

2. Assignor hereby authorizes the Commissioner of Patents and Trademarks of the United States, and any officials of any countries foreign to the United States whose duty it is to record trademark registrations, applications and title thereto, to record the Trademarks, and title thereto as the property of Assignee in accordance with the terms of this Trademark Assignment.

3. This Trademark Assignment shall be binding upon and inure to the benefit of the parties and their respective successors and assigns.
