TRADEMARK SECURITY RELEASE AGREEMENT

This TRADEMARK SECURITY RELEASE AGREEMENT is dated as of June 24, 2022 (the “**Release**”) and executed and delivered by UBS AG, STAMFORD BRANCH, in its capacity as collateral agent (in such capacity, the “**Collateral Agent**”) in favor of C.H.I. OVERHEAD DOORS, LLC (as successor by merger to C.H.I. Overhead Doors, Inc.) (“**C.H.I.**”) and PERFORMAX GLOBAL LLC (“**PerforMax**” and, together with C.H.I., the “**Grantors**”). Capitalized terms used and not otherwise defined herein shall have the meanings ascribed to such terms in the First Lien Credit Agreement (as defined below).

WHEREAS, reference is made to that certain Credit Agreement, dated as of July 31, 2015 (as amended by the Joinder Agreement, dated as of November 29, 2016, as further amended by the First Amendment to Credit Agreement, dated as of February 16, 2017, as further amended by the Assumption, Joinder and Reaffirmation Agreement, dated as of May 30, 2018, as further amended by the Second Amendment to Credit Agreement, dated as of August 17, 2018, as further amended by the Third Amendment to Credit Agreement, dated as of October 15, 2020, and as otherwise amended, restated, supplemented and otherwise modified through the date hereof, the “**First Lien Credit Agreement**”), made by and among C.H.I. and Collateral Agent, among other parties.

WHEREAS, pursuant to the First Lien Credit Agreement, C.H.I. and Collateral Agent entered into that certain Security Agreement, dated as of July 31, 2015, which was recorded with the United States Patent and Trademark Office, (the “**USPTO**”) on July 29, 2016, at Reel 5929, Frame 0196, and PerforMax and Collateral Agent entered into that certain Security Agreement, dated June 3, 2019, which was recorded with the USPTO on June 6, 2019 at Reel 6664, Frame 0241 (collectively, the “**Trademark Security Agreements**”);

WHEREAS, pursuant to the terms of the Trademark Security Agreements, the Grantors granted a lien on and security interest in all of the Grantors’ right, title, and interest in, to and under the Trademarks (excluding any Excluded Property), including the Trademarks set forth on **Schedule I** attached hereto, the goodwill associated therewith and the right to receive all Proceeds therefrom (the foregoing, the “**Trademark Collateral**”);

WHEREAS, the Collateral Agent now desires to release its security interest granted pursuant to the Trademark Security Agreements in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby covenants and agrees as follows:

SECTION 1. The Collateral Agent does hereby release and convey, without recourse, representation or warranty of any kind, all of its right, title and interest (including its security interest) in, to and under the Trademark Collateral granted pursuant to the Trademark Security Agreements, and reassigns to the Grantors all right, title, and interest that Collateral Agent may have in, to and under the Trademark Collateral pursuant to the Trademark Security Agreements;


SECTION 2. The Collateral Agent agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts, in each case at the Grantors' expense, as may be reasonably necessary to effect the release of the security interest in the Trademark Collateral contemplated hereby; and

SECTION 3. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
