The undersigned, on behalf of Asymmetrik Ltd, a Maryland corporation (the "**Company**"), hereby files these articles of conversion (these "**Articles**") with the Maryland State Department of Assessments and Taxation ("**SDAT**") for the purposes of converting the Company from a Maryland corporation to a Maryland limited liability company under Section 3-903 of the Maryland General Corporation Law (the "**MGCL**") and Section 4A-1103 of the Maryland Limited Liability Company Act (the "**LLC Act**") and certifies:

- FIRST:** The Company was formed by the filing of Articles of Incorporation with SDAT on August 3, 2011 under the name "Asymmetrik Ltd". The name of the Company immediately prior to the filing of these Articles is "Asymmetrik Ltd".
- SECOND:** By virtue of these Articles and the Articles of Organization filed with the SDAT on the date hereof, the Company is converting into a Maryland limited liability company under and pursuant to the MGCL and the LLC Act.
- THIRD:** The name of the Maryland limited liability company into which the Company shall be converted is "BlueHalo Cyber Solutions, LLC" (the "**Converted Entity**").
- FOURTH:** Upon the completion of the conversion in accordance with the MGCL and the LLC Act, the Converted Entity shall, for all purposes of the laws of the State of Maryland, continue as the same entity as the Company.
- FIFTH:** The conversion has been approved in accordance with Section 3-903 of the MGCL and Section 4A-1103 of the LLC Act.
- SIXTH:** The manner and basis of converting the issued and outstanding shares of stock in the Company into membership interests in the Converted Entity is as follows, each of which shall automatically be effected by virtue of the

conversion without any further action by any person: Upon completion of the conversion, each issued and outstanding share of stock in the Company will be immediately converted into one unit of limited liability company interest in the Converted Entity.

SEVENTH: The conversion shall be effective as of 12:01 am EDT on June 1, 2022.

EIGHTH: The location of the principal office of the Converted Entity in the State of Maryland is: 308 Sentinel Drive, Suite 400, Annapolis Junction MD 20701.

NINTH: The name and address of the resident agent of the Converted Entity in the State of Maryland is: The Corporation Trust Incorporated – 2405 York Road, Suite 201, Lutherville Timonium MD 21093-2264.

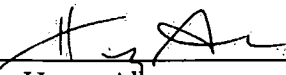

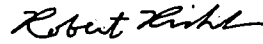
