**RELEASE OF SECURITY INTEREST IN
PATENT AND TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN PATENT AND TRADEMARK COLLATERAL** (the “Release”), dated as of June 24, 2022, is made by U.S. BANK NATIONAL ASSOCIATION, as collateral agent (together with its successors and assigns in such capacity, the “Collateral Agent”) for the benefit of the Secured Parties (as defined in the Collateral Agreement (as defined below)), in favor of AMERICAN WAGERING, INC., a Nevada corporation, and WH NV III, LLC, a Delaware limited liability company (together, the “Pledgors”).

WITNESSETH

WHEREAS, the Pledgors, each other pledgor identified in the Collateral Agreement and the Collateral Agent are parties to that certain Collateral Agreement, dated as of July 20, 2020 (as amended, restated, supplemented, waived or otherwise modified from time to time, the “Collateral Agreement”);

WHEREAS, pursuant to the Collateral Agreement, each Pledgor executed and delivered to the Collateral Agent that certain Patent and Trademark Security Agreement, dated as of June 4, 2021 (the “Patent and Trademark Security Agreement”) and recorded with the United States Patent and Trademark Office (“USPTO”) on June 7, 2021 at Reel/Frame Nos. 7318/0863, 7318/0871 and 056497/0040, pursuant to which each Pledgor granted to the Collateral Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest in all of such Pledgor’s right, title and interest in or to any and all of the IP Collateral (as defined in the Patent and Trademark Security Agreement); and


WHEREAS, each Pledgor has requested that the Collateral Agent, and the Collateral Agent has agreed to, release its security interest in all right, title and interest in or to the IP Collateral in connection with such Pledgor’s release from the Collateral Agreement.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in or to the IP Collateral, including the patents listed on Schedule I hereto and the trademarks listed on Schedule II hereto, and agrees that all the security interest in the IP Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the applicable Pledgor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the IP Collateral under the Collateral Agreement and the Patent and Trademark Security Agreement, and authorizes and requests that this Release be recorded with the USPTO.
