NUNC PRO TUNC ASSIGNMENT

Assignors further assigns to Assignee all right to sue for and receive all damages accruing from past infringement and/or dilution of the Trademark assigned.

This Assignment shall be binding upon the parties, their successors and/or assigns and all others acting by, through, with or under their direction, and all those in privity therewith.
