**TRADEMARK ASSIGNMENT**

This Trademark Assignment (this "Assignment") is effective as of June 27, 2022 (the "Effective Date"), by NCI GROUP, INC., a company incorporated under the laws of Nevada (hereinafter "*Assignor*"), having a business address of 13105 Northwest Freeway, Suite 50, Houston, Texas 77040 and METAL COATERS, LLC, a limited liability company formed under the laws of Delaware (hereinafter "*Assignee*"), having a business address of 13105 Northwest Freeway, Suite 50, Houston, Texas 77040.

WHEREAS, *Assignor* owns the entire right, title, and interest the U.S. trademarks, and their corresponding federal registrations, listed in Exhibit A attached hereto and incorporated herein by reference ("*U.S. Trademarks*") and the U.S. state trademarks, and if applicable, their corresponding state registrations, listed in Exhibit B attached hereto ("*State Trademarks*"), incorporated herein by reference, collectively sometimes referred to herein as "*Marks*;" and

WHEREAS, pursuant to that certain Membership Interest Purchase Agreement dated April 10, 2022, by and between Cornerstone Building Brands, Inc., and Bluescope Steel North America Corporation, *Assignor* has agreed to convey, assign and transfer to *Assignee* all of *Assignor's* rights in the Marks, together with the goodwill of the business with which such Marks are used, and which is symbolized by such Marks, and any and all associated common law rights, statutory, and other rights *Assignor* has in such Marks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, *Assignor* does hereby convey, assign, and transfer to *Assignee* its entire right, title and interest in and to the *U.S. Trademarks* listed in Exhibit A and the *State Trademarks* listed in Exhibit B, together with the goodwill of the business connected with the use of, and symbolized by such Marks, and any and all associated common law rights, statutory, and other rights, as well as all rights of enforcement and recovery for past infringement, together with the right, but not the obligation, to sue and recover damages and relief in *Assignee's* own name, to have and to hold the same for *Assignee's* own use and benefit and for the benefit of *Assignee's* successors, assigns, and legal representatives.

*Assignor* agrees to execute any and all powers of attorney, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such right, title, and interest in *Assignee*.

This *Assignment* shall be binding on each party's successors, assigns, and legal representatives.

*Governing Law.* This *Assignment* and any claim, controversy, dispute, or cause of action (whether in contract, tort, or otherwise) based upon, arising out of, or relating to this Assignment and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of Delaware, without giving effect to any choice or conflict of law provision or rule (whether of the State of Delaware or any other jurisdiction).

This *Assignment* may be executed in multiple counterparts, each of which when executed shall be deemed to be an original and all of which taken together shall constitute one and the same instrument. A signed copy of this *Assignment* delivered by email, facsimile, or other electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this *Assignment*.
