**TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** is dated as of June 27, 2022 and made by BANK OF AMERICA, N.A., successor in interest to LaSalle National Bank, having an office at 135 South LaSalle Street, Suite 425, Chicago, Illinois 60603, "(LaSalle Bank", to Bullet Line, LLC, a Pennsylvania limited liability company, having an office at 6301 E. 10th Avenue, Hialeah, Florida 33013, (the "Company"), successor in interest to Sun Manufacturing Corporation, a Florida corporation, ("Sun Manufacturing").

WHEREAS, Sun Manufacturing and LaSalle Bank entered into that certain Trademark Security Agreement, dated September 23, 1998 (as amended, the "Security Agreement"), in which a security interest was granted by Sun Manufacturing in favor of LaSalle Bank in certain Trademarks (as such terms are defined in the Security Agreement);

WHEREAS, the Security Agreement was originally recorded in the Trademark Division of the United States Patent and Trademark Office on October 14, 1998, at Reel 1801, Frame 0353; and

WHEREAS, BANK OF AMERICA, N.A., now desires to terminate and release the Security Agreement.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, BANK OF AMERICA, N.A., hereby states as follows:

1. Definitions. The term "Trademarks", as used herein, shall have the meanings set forth in the Security Agreement and shall mean and include all of the Company's right, title and interest of every kind and nature as of the date hereof, including in the trademarks listed on Exhibit A attached hereto.

2. Release of Security Interest. BANK OF AMERICA, N.A., hereby terminates the Security Agreement, and terminates, releases and discharges its security interest in the Trademarks and reassigns to the Company all right, title and interest it may have in and to the Trademarks without recourse and without any representation or warranty.
