TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST

This TERMINATION AND RELEASE (this “Release”) is dated as of June 24, 2022 (the “Release Date”), by TRUIST BANK, as Administrative Agent for the Secured Parties (as defined in the Guaranty and Security Agreement) (in such capacity, the “Agent”), for the benefit of each of INTERNATIONAL CREATIVE MANAGEMENT PARTNERS LLC, a Delaware limited liability company and SELECT SPORTS GROUP, LLC, a Texas limited liability company (each a “Grantor” and collectively, the “Grantors”).

WHEREAS, pursuant to that certain Guaranty and Security Agreement, dated as of March 22, 2022, by and among the Agent, the Grantors and certain other parties thereto (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Guaranty and Security Agreement”), the Grantors granted to the Agent, in its capacity as collateral agent, a security interest in and to certain collateral;

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of March 22, 2022, by the Grantors in favor of the Agent (the “Trademark Security Agreement”), each Grantor pledged and granted to the Agent a lien on and security interest in and to all of its right, title and interest in, to and under certain Trademark Collateral (as defined in the Trademark Security Agreement), including all of the Trademark Collateral set forth in Schedule I hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (the “USPTO”) on March 23, 2022 at Reel/Frame 7669/0452; and

WHEREAS, the obligations of the Grantors to the Agent have been paid in full and the Grantors have requested that the Agent release its security interest in the Trademark Collateral.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees as follows:

1. Release of Security Interest. Effective as of the Release Date, the Agent hereby, without any representation and warranty and without any recourse (a) terminates the Liens (as defined in the Bridge Loan Agreement) and security interests created under the Trademark Security Agreement in the Trademark Collateral, (b) discharges any and all rights, title and interest it has in and the security interest granted to the Agent in the Trademark Collateral, (c) terminates the Trademark Security Agreement except for any provisions therein that expressly survive termination, and (d) assigns, grants and conveys to the applicable Grantor any and all of Agent’s right, title and interest in and to the Trademark Collateral.

2. Recordation of Release. The Agent understands and agrees that this Release may be recorded by or for each Grantor with the USPTO.

3. Further Actions. The Agent further agrees to execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that the Grantors may reasonably require to effect the intent and purpose of this Release; provided, that all such

documents are to be prepared by counsel to such Grantor and the cost and expense of such documents and actions shall be borne solely by such Grantor.


4. Capitalized Terms. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Trademark Security Agreement or Guaranty and Security Agreement, as applicable.

5. Governing Law. This Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law principles.
