NOW FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Secured Party hereby releases and discharges all liens and security interests granted by Grantee or assigned by First Interest Holder in favor of Secured Party, as successor-in-interest to First Interest Holder, in the right, title and interest in, to and under any and all assets owned or acquired by Grantee, or in which Grantee now has, all United States trademarks, service marks, corporate names, company names, business names, trade dress, logos and taglines, all registrations thereof (if any), and all registration and registration applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office, and all renewals thereof, including, but not limited to, those listed on Schedule I, as well as all goodwill associated therewith or symbolized thereby.
