SUPPLEMENT TO
INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Supplement to Intellectual Property Security Agreement (this “*Supplement*”) is made as of May 9, 2022 by and between **SILICON VALLEY BANK**, a California corporation, in its capacity as administrative agent and collateral agent (“*Agent*”), and **GROVE COLLABORATIVE, INC.** a Delaware public benefit corporation (as “*Grantor*”).

WHEREAS, Grantor executed and delivered an Intellectual Property Security Agreement dated April 30, 2021 (as amended and/or supplemented from time to time hereinafter, the “*IP Agreement*”) in favor of the Agent, for the ratable benefit of the Lenders, pursuant to which Grantor pledged, assigned and granted a security interest in certain Intellectual Property Collateral, which was recorded with the Trademark division of the United States Patent and Trademark Office on April 30, 2021 at Reel 7276, Frame 0289 and the Patents division of the United States Patent and Trademark Office on April 30, 2021 at Reel 056096, Frame 0316.

WHEREAS, the Grantor has developed additional Intellectual Property Collateral, and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional intellectual property in favor of Agent, for the ratable benefit of the Lenders.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the IP Agreement.
2. Supplement to Exhibit C. Exhibit C to the IP Agreement is hereby supplemented, but not replaced, by Exhibit A annexed hereto.
3. Miscellaneous:
 - a. Except as provided herein, all terms and conditions of the IP Agreement remain in full force and effect. The Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.
 - b. This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
 - c. Each party hereto may execute this Supplement by electronic means and recognizes and accepts the use of electronic signatures and records by any other party hereto in connection with the execution and storage hereof.
