## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) dated as of June 29, 2022, is made by FORTRESS CREDIT CORP., as collateral agent acting for the benefit of the Secured Parties (the “**Collateral Agent**”) in favor of MAIN EVENT ENTERTAINMENT, INC., a Florida corporation, and BOTANIC ELECTRIC, INC., a Florida corporation, (each a “**Grantor**” and collectively, the “**Grantors**”). Capitalized terms not defined herein shall have the meaning ascribed to them, directly or by reference, in the Trademark Security Agreement (as defined below).

WHEREAS, the Grantors, certain other grantors and the Collateral Agent are party to that certain Security Pledge Agreement, dated as of April 4, 2019 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Security Pledge Agreement**”) pursuant to which the Grantors executed and delivered that certain Grant of Security Interest in Trademark Rights, dated as of April 4, 2019, in favor of the Collateral Agent (the “**Trademark Security Agreement**”);

WHEREAS, pursuant to the Security Pledge Agreement and the Trademark Security Agreement, each Grantor pledged and granted a continuing security interest in, and a right of setoff against (the “**Security Interest**”), such Grantor’s right, title and interest in, to and under all of the Trademarks owned by such Grantor and constituting Collateral, including, without limitation, those listed on Schedule A hereto (collectively, the “**Trademark Collateral**”), to the Collateral Agent, for the benefit of the Secured Parties, to secure payment, performance and observance of the Secured Obligations.

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office (the “**USPTO**”) on April 4, 2019 at Reel/Frame 6610/0217;

WHEREAS the Grantor has requested that the Collateral Agent now terminate and release the Security Interest in the Trademark Collateral;


NOW THEREFORE, in consideration of the foregoing and for other good and valuable consideration the receipt and adequacy of which are hereby acknowledged, the Collateral Agent hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels and releases the Security Interest in the Trademark Collateral, and (iii) reassigns to each Grantor all right, title and interest, if any, that the Collateral Agent may hold in the Trademark Collateral of such Grantor, in each case without recourse to the Collateral Agent, and without representation or warranty of any kind.

Each Grantor, and any successor to such Grantor (including any person or entity hereafter holding any right, title or interest in, to or under the Trademark Collateral of such Grantor) is hereby authorized to record this Release in the USPTO.
