This Trademark Assignment shall be binding upon the successors and assigns of Assignor and Assignee. No supplement, modification or amendment of this Trademark Assignment shall be binding unless executed in writing by Assignor and Assignee.

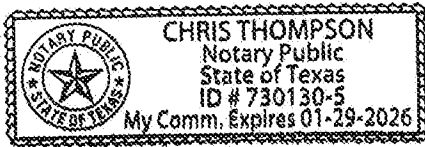
