**TERMINATION AND RELEASE OF SECURITY INTEREST
IN PATENTS AND TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS**, dated as of June 29, 2022 ("Release"), is made by FIRST HORIZON BANK, as successor in interest to IBERIABANK, as Administrative Agent ("Administrative Agent") in favor of EASTPORT HOLDINGS, LLC, a Tennessee limited liability company (the "Pledgor").

WHEREAS, pursuant to that certain Grant of Security Interest in Patents and Trademarks dated January 12, 2016, by and between Administrative Agent and Pledgor (the "Security Agreement"), which was recorded at the United States Patent and Trademark Office ("USPTO") on January 15, 2016 at Reel/Frame 5710/0504 ("Notice"), Pledgor granted to Administrative Agent a security interest in any and all of Pledgor's right, title, and interest in and to certain Trademarks and Patents, including the Trademarks and Patents listed on Schedule A attached hereto.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent agrees as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreements.

SECTION 2. Termination and Release. Administrative Agent, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in all of its right, title and interest in and to the Trademarks and Patents and the use thereof, together with all income, royalties, damages and other payments, proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks, granted pursuant to the Security Agreements; and

(b) authorizes the recordation of this Release with the USPTO at Pledgor's expense.
