RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property (“**Release**”) is made as of June 24, 2022, (“**Effective Date**”) by **SILICON VALLEY BANK**, a California corporation (“**Bank**”) in favor of **INTERACTIONS LLC**, a Delaware limited liability company (“**Grantor**”). Capitalized terms used but not otherwise defined herein have the meaning given to them in the applicable IP Security Agreement (as defined below).

Recitals

WHEREAS, pursuant to (i) that certain Amended and Restated Loan and Security Agreement, dated as of February 25, 2014, between Bank and the Grantor, as amended, restated, amended and restated, supplemented or otherwise modified from time to time (the “**AR LSA**”), (ii) that certain Second Amended and Restated Loan and Security Agreement, dated as of June 29, 2017, by and among the Bank, the Grantor, and Interactions Corporation (the “**Parent**”), as amended, restated, amended and restated, supplemented or otherwise modified from time to time (the “**2nd AR LSA**”), which amends and restates the AR LSA in its entirety, and (iii) that certain Mezzanine Loan and Security Agreement, dated as of June 3, 2019, by and among the Bank, the Grantor, and the Parent, as amended, restated, amended and restated, supplemented or otherwise modified from time to time (the “**Mezz LSA**”, and together with the AR LSA and 2nd AR LSA, each a “**Loan Agreement**” and collectively, the “**Loan Agreements**”), Bank agreed to make certain advances of money and to extend certain financial accommodations to Grantor and the Parent and certain other parties in the amounts and manner set forth in the Loan Agreement;

WHEREAS, pursuant to the Loan Agreements, Grantor executed those certain agreements described on Annex I attached hereto (the “**IP Security Agreements**”), in favor of Bank, whereby Grantor granted to Bank a security interest in all of the Intellectual Property Collateral, including, without limitation those properties listed on Annex II attached hereto, to secure the Obligations (as defined in the applicable Loan Agreement); and

WHEREAS, Grantor has requested Bank release its security interest in all right, title and interest in, to and under all of the Intellectual Property Collateral, terminate the IP Security Agreements, and reassign its interest to Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, Bank hereby agrees as follows:

Agreement

1. Bank hereby terminates the IP Security Agreements and releases, terminates and discharges, without representation, recourse or warranty whatsoever, all of its rights in, to and under, including its security interest in, and right of setoff against, all of the Intellectual Property Collateral, whether granted in connection with the Loan Agreement, the IP Security Agreements or any other agreement or document delivered in connection with any Loan Agreement or any IP Security Agreement, and Bank hereby reassigns any and all right, title and interest (if any) that Bank may have in, to or under all of the Intellectual Property Collateral to Grantor.
2. Bank agrees, at Grantor’s expense, to cooperate with Grantor and to provide Grantor with the

information and additional authorization reasonably required or desirable to effect the release of Bank's security interest in the released Intellectual Property Collateral described herein.


3. Bank authorizes Grantor or Grantor's authorized representative or designee to record this Release with the United States Patent and Trademark Office and U.S. Copyright Office or any other governmental entities as evidence of such release and termination.
