CONFIRMATION OF INTELLECTUAL PROPERTY SECURITY

THIS CONFIRMATION OF INTELLECTUAL PROPERTY SECURITY (this “**Confirmation**”), dated for reference May 27, 2022, is made by STEMCELL Technologies Canada Inc., STEMCELL Technologies Inc., STEMCELL International Inc., Malachite Management Inc., Connexon Creative Inc., STEMCELL Technologies (Australia) Holdings Pty Ltd., STEMCELL Technologies, Singapore Pte. Ltd., and STEMCELL Technologies UK Ltd. (collectively, the “**Grantors**” and each, a “**Grantor**”) in favour of HSBC Bank Canada, in its capacity as Agent (the “**Secured Party**”) under the amended and restated credit agreement between, among others, the Grantors and the Secured Party, made as of May 27, 2022 (as the same may be amended, restated, supplemented, or otherwise modified from time to time, the “**Credit Agreement**”).

WHEREAS:

A. Each of the Grantors (as applicable) is the listed owner of the Canadian trademark applications and registration, and patent applications listed in Schedule "A" hereto (collectively, the “**Canadian Trademarks and Patents**”);

B. Each of the Grantors (as applicable) is the listed owner of the United States trademark applications and registrations and patent applications and patents listed in Schedule "B" hereto (collectively, the “**US Trademarks and Patents**”);

C. Each of the Grantors (as applicable) is the listed owner of the United Kingdom trademark applications and registrations and patent applications and patents listed in Schedule "C" hereto (collectively, the “**UK Trademarks and Patents**”);

D. Each of the Grantors (as applicable) is the listed owner of the Singaporean trademark applications and registrations and patent applications and patents listed in Schedule "D" hereto (collectively, the “**Singapore Trademarks and Patents**”);

E. Each of the Grantors (as applicable) is the listed owner of the Australian trademark applications and registrations and patent applications and patents listed in Schedule "E" hereto (collectively, the “**Australia Trademarks and Patents**” and, together with the Canadian Trademarks and Patents, the US Trademarks and Patents, the UK Trademarks and Patents and the Singapore Trademarks and Patents, the “**Intellectual Property**”);

F. As required under the Credit Agreement, the Grantors have entered into certain security agreements as collateral security for the payment and performance of certain obligations as more fully described therein (the “**Security Document**”), pursuant to which each Grantor granted to the Secured Party a security interest in and to, now and hereafter, among other things, the Intellectual Property;

G. The Grantors and the Secured Party have perfected (rendered opposable against third parties) the Security Document in the Intellectual Property in accordance with applicable law; and

H. The Grantors and the Secured Party have agreed to enter into this Confirmation for the purposes of recording the Security Document and the security created thereunder in the Intellectual Property with the Canadian Intellectual Property Office (the “**CIPO**”), the United States Patent and Trademark Office (the “**USPTO**”), the United Kingdom Intellectual Property Office (the “**UKIPO**”), the Intellectual Property Office of Singapore (the “**IPOS**”) and IP Australia (as applicable).


NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, each Grantor and the Secured Party hereby agree as follows:

1. The Grantors and the Secured Party hereby confirm that they have entered into the Security Document and that, pursuant to the Security Document, each Grantor has granted to, and in favour of, the Secured Party a security interest in and to, now and hereafter, among other things, the Intellectual Property. Notwithstanding anything herein to the contrary, the security interest with respect to the Intellectual Property comprising trademark applications and registrations constitutes a security interest in such Intellectual Property in favour of the Secured Party, but does not constitute an assignment or mortgage of such Intellectual Property to the Secured Party.
2. Each Grantor and the Secured Party hereby acknowledge and affirm that the rights and remedies of the Secured Party with respect to the security interest in, the Intellectual Property are more fully set forth in the Security Document and that in the event of a conflict between the provisions of this Confirmation and the provisions of the Security Document, the terms of the Security Document shall control.
3. Each Grantor and the Secured Party hereby authorize and request that the commissioner, registrar or any other applicable government officer of the CIPO record this Confirmation with respect to the Canadian Trademarks and Patents.
4. Each Grantor and the Secured Party hereby authorize and request that the commissioner, registrar or any other applicable government officer of the USPTO record this Confirmation with respect to the US Trademarks and Patents.
5. Each Grantor and the Secured Party hereby authorize and request that the commissioner, registrar or any other applicable government officer of the UKIPO record this Confirmation with respect to the UK Trademarks and Patents.
6. Each Grantor and the Secured Party hereby authorize and request that the commissioner, registrar or any other applicable government officer of the IPOS record this Confirmation with respect to the Singapore Trademarks and Patents.
7. Each Grantor and the Secured Party hereby authorize and request that the commissioner, registrar or any other applicable government officer of IP Australia record this Confirmation with respect to the Australia Trademarks and Patents.
8. This Confirmation may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
9. This Confirmation and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the Province of British Columbia and the federal laws of Canada applicable therein, without regard to the conflict of law principles.
