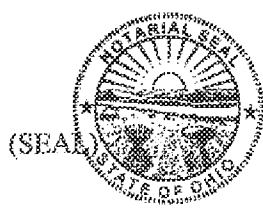
Principle Business Enterprises, Inc. warrants that it is the legal owner of the MARK and that this assignment does not infringe on the rights of any person.
