## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT (Assignment"), dated as of June 9, 2022 (the "Effective Date") is made and entered into by Accumetrics, Inc., a Delaware corporation with a business address 3985 Sorrento Valley Blvd., San Diego, CA 92121 (the "Assignor") in favor of Accriva Diagnostics, Inc., a Delaware corporation with a business address of 6260 Sequence Drive, San Diego, CA 92121 (the "Assignee"). The Assignor and Assignee are sometimes individually referred to herein as a "Party" and collectively as the "Parties."

WHEREAS, Assignor and Assignee are related companies; and

Assignment. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably conveys, transfers, and assigns to Assignee, and Assignee accepts from Assignor, all of Assignor's right, title, and interest in and to the trademarks, tradenames and business names listed on the attached Schedule A, including all registrations and applications set forth on said Schedule, and all issuances, extensions, and renewals thereof (collectively, the "**Trademarks**"), together with the goodwill of the business connected with the use of, and symbolized by, the Trademarks; and any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on, or after the date hereof, including all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

Assignor further agrees, upon request, to execute and deliver any additional documents necessary to effectuate the foregoing assignment of rights, including documents of transfer that may be necessary to record the transfer with any government or administrative agency.
