**CERTIFICATE OF AMENDMENT OF THE  
AMENDED AND RESTATED CERTIFICATE OF INCORPORATION OF  
VOLOAGRI GROUP, INC.**

VoloAgri Group, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the “**Corporation**”),

DOES HEREBY CERTIFY:

**FIRST:** That the name of the Corporation is VoloAgri Group, Inc. The Corporation was originally incorporated under the same name.

**SECOND:** That the Corporation’s original Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on August 3, 2012. An amended and restated Certificate of Incorporation of the Corporation was most recently filed with the Secretary of State of the State of Delaware on April 23, 2021. This amendment amends and restates the provisions of the Amended and Restated Certificate of Incorporation of the Corporation as provided herein.

**THIRD:** Article First of the Amended and Restated Certificate of Incorporation of the Corporation shall be amended by deleting it in its entirety and substituting the following therefore:

**“FIRST:** The name of this corporation is Axia Vegetable Seeds Group, Inc. (the “**Corporation**”).”

**FOURTH:** This amendment of the Amended and Restated Certificate of Incorporation herein certified has been duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.
