RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Release”) is made as of June 30, 2022, by **GOLDMAN SACHS BANK USA**, in its capacity as collateral agent under the security agreements referred to below (“Collateral Agent”), in favor of **WATCHGUARD TECHNOLOGIES, INC.**, a Washington Corporation (“Grantor”).

WHEREAS, reference is hereby made to (a) that certain Security Agreement (as supplemented or otherwise modified from time to time), dated as of June 1, 2020, executed by Grantor in favor of Collateral Agent (the “Security Agreement”), and (b) that certain Trademark Security Agreement (as supplemented or otherwise modified from time to time), dated as of June 1, 2020, executed by Grantor in favor of Collateral Agent (the “Trademark Security Agreement”), and recorded in the records of the United States Patent and Trademark Office on June 1, 2020 at Reel/Frame 6950/0016; and

WHEREAS, pursuant to the above-referenced security agreements, Grantor granted to Collateral Agent a security interest in and continuing lien on all of Grantor’s right, title and interest in and to the following, in each case whether now owned or existing or hereafter acquired, possessed or arising and wherever located (collectively, the “Trademark Collateral”), other than Excluded Property:

- (i) all trademarks, service marks, designs, logos, indicia of origin, trade names, trade dress, corporate names, company names, business names, fictitious business names, trade styles and/or other source and/or business identifiers and applications pertaining thereto, whether registered or unregistered (including, without limitation, those set forth on Schedule A annexed hereto), and all renewals and extensions thereof and all rights corresponding thereto;
- (ii) all goodwill of Grantor’s business connected with the use of and symbolized by any of the foregoing;
- (iii) the right to sue or otherwise recover for any past, present and future infringement, dilution, or other violation or impairment of any of the foregoing; and
- (iv) all Proceeds and Accessions with respect to any of the foregoing, including all license fees, royalties, income, payments, claims, damages and proceeds of suit, now or hereafter due and/or payable with respect to any of the foregoing.

Unless otherwise defined herein, terms defined in the Security Agreement or Trademark Security Agreement and used herein have the meanings given to them (including by reference) in the Security Agreement or the Trademark Security Agreement, as applicable.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Collateral Agent hereby (i) terminates and releases all security interests and continuing liens granted by Grantor in favor of Collateral Agent in the Trademark Collateral; (ii) assigns, transfers and delivers to Grantor all of its right, title and interest in and to the Trademark Collateral to the extent that any such right, title and interest exists as of the date hereof; (iii) authorizes Grantor or its designee to make filings with the United States Patent and

Trademark Office and to take further actions necessary to evidence the release and termination of Collateral Agent's security interests in and liens on the Trademark Collateral; and (iv) authorizes the governing body of the United States Patent and Trademark Office to record this Release.
