RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this “Release”) is dated as of June 9, 2022, and delivered by TC Lending, LLC, in its capacity as collateral agent for the secured parties (in such capacity, the “Collateral Agent”) in favor of NETWRIX CORPORATION, a Delaware corporation, STEALTHBITS TECHNOLOGIES II LLC, a New Jersey limited liability company and POLICYPAK SOFTWARE, LLC, a Delaware limited liability company (each, a “Grantor”, and collectively, the “Grantors”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Credit Agreement (as defined below) or the IP Security Agreement (as defined below).

WHEREAS, pursuant to that certain Credit Agreement, dated as of September 30, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, including pursuant to that certain First Amendment to the Credit Agreement, dated as of December 31, 2020 and that certain Second Amendment to the Credit Agreement, dated as of March 23, 2021, the “Credit Agreement”), by and among NETWRIX CORPORATION, a Delaware corporation (the “Borrower”), NWRX ACQUISITION, INC., a Delaware corporation (“Holdings”), each of the other Guarantors party thereto from time to time, the Lenders party thereto from time to time, and TC LENDING, LLC, a Delaware limited liability company, as administrative agent for the Lenders and as collateral agent for the Secured Parties (in such capacity, together with its successors and assigns in such capacity, “Agent”), in order to secure payments of certain Obligations, the Grantors were required to execute and deliver Trademark Security Agreement dated as of March 25, 2022 (the “PolicyPak Trademark Security Agreement”), Trademark Security Agreement dated as of December 31, 2020 (the “Stealthbits Trademark Security Agreement”), Trademark Security Agreement dated as of September 30, 2020 (the “Initial Trademark Security Agreement”), Patent Security Agreement dated as of December 31, 2020 (the “Stealthbits Patent Security Agreement”) and Copyright Security Agreement dated as of September 30, 2020 (the “Copyright Security Agreement”) and collectively, as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) and pursuant thereto the Grantors pledged and granted to Lender, as grantee thereunder, a first priority security interest in all of the Grantors’ right, title and interest in, to and under its Trademarks, Patents and Copyrights, including without limitation those Trademarks, Patents and Copyrights listed on Schedules I, II and III, respectively, hereto, and including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof (collectively, the “Intellectual Property”).

WHEREAS, pursuant to the Security Agreement, (i) a security interest in the Trademarks was recorded with the United States Patent and Trademark Office on March 25, 2022 at Reel/Frame 007671/0699, (ii) a security interest in the Trademarks was recorded with the United States Patent and Trademark Office on December 31, 2020 at Reel/Frame 007153/0357, (iii) a security interest in the Trademarks was recorded with

the United States Patent and Trademark Office on September 30, 2020 at Reel/Frame 007066/0086, (iv) a security interest in the Patents was recorded with the United States Patent and Trademark Office on December 31, 2020 at Reel/Frame 054884/0804, and (v) a security interest in the Copyrights was recorded with the United States Copyright Office on September 30, 2020 at Volume/Doc Id 9974/272.

WHEREAS, Lender acknowledges the full payment and performance of the Obligations, and as a result desires to terminate and release its security interest in the Intellectual Property.


NOW, THEREFORE, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby terminates, releases and forever discharges any and all security interests it has in the Intellectual Property, terminates the Security Agreement, and retransfers and reassigns to the Grantors without representation or warranty of any kind, express or implied, free and clear of any claims by Lender, all right, title or interest of Lender in, to or under the Intellectual Property of the Grantors.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
