

1. Confirms that it sold, assigned, transferred and conveyed to Assignee, its successors and assigns, the whole entire right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks, and all rights to sue for and collect damages resulting from past, present and future infringement of any or all Trademarks in the United States and Canada.

2. Authorizes and requests the U.S. Patent & Trademark Office ("USPTO") and the Canadian Intellectual Property Office ("CIPO") to issue or transfer all the Trademarks to Assignee, as assignee of the entire right, title, and interest therein or otherwise as Assignee may direct.


