## Intellectual Property Assignment Agreement

This Intellectual Property Assignment Agreement (this "**Assignment Agreement**") is entered into as of April 1, 2022 ("**Effective Date**") by and between Glu Mobile LLC, a Delaware limited liability company formerly known as Glu Mobile Inc. ("**Assignor**"), and Electronic Arts Inc., a Delaware corporation ("**Assignee**"). Both Assignor and Assignee are collectively referred to herein as the "**Parties**."

### RECITALS

WHEREAS, on December 31, 2021, Assignor converted from Glu Mobile Inc., a Delaware corporation, to Glu Mobile LLC, a Delaware limited liability company;

WHEREAS, Assignor and Assignee have entered into that certain Intellectual Property Distribution Agreement dated April 1, 2022 (the "**Agreement**");

WHEREAS, pursuant to the Agreement, Assignor assigned to Assignee inter alia all Intellectual Property Rights (as defined herein) relating to Assignor's business; and

WHEREAS, Assignor wishes to confirm Assignee's ownership of the Intellectual Property Rights and the assignment to Assignee of any right, title and interest that Assignor may have in and to the Intellectual Property Rights.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Assignor hereby transfers, assigns and conveys to Assignee all of Assignor's right, title and interest, of whatever kind and nature forever and throughout the universe, including all causes of action, in either law or equity, for past, present, and future claims, in and to the Intellectual Property Rights. "**Intellectual Property Rights**" shall mean and include (a) any and all inventions, patents, and patent applications, works of authorship, copyrights, and copyright applications and registrations, domain names, computer programs (in source code and object code form), flow charts, formulae, enhancements, updates, translations, adaptations, information, specifications, designs, process technology, manufacturing requirements, quality control standards, marketing intangibles, trade secrets and trade secret rights and any other intangible property rights anywhere in the world and (b) any and all trademarks, service marks and trade names, and applications or registrations therefor and all related goodwill. For the sake of clarity, "Intellectual Property Rights" include but are not limited to the registered intellectual property set forth on Schedule 1 attached hereto (trademark/service marks, copyrights and applications) and all rights to receive any of the foregoing, rights corresponding to the foregoing and all proceeds thereof. In the event that any Intellectual Property Right that is owned by, or filed in the name of, Assignor, but not included in Schedule 1 is identified, discovered or found, then Assignor shall duly transfer, assign and convey such Intellectual Property Right to Assignee and such Intellectual Property Right shall be deemed to be incorporated and be deemed part of such Schedule 1. Assignor represents that Assignor has all of the rights, titles, and interests to convey the Intellectual Property Rights as set forth herein, and covenants that Assignor has not made any assignment, grant, mortgage, license, or other agreement affecting the rights, titles, and interests herein conveyed except as may have occurred within the ordinary course of Assignor's business.
2. Assignor hereby authorizes the relevant authority at the Patents and Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office and/or the

applicable foreign authorities outside the United States, as applicable, to record Assignee as the assignee and owner of the applicable Assigned Marks and Assigned Patents. Assignor hereby authorizes the relevant authority at the United States Copyright Office and/or the applicable foreign authorities outside the United States, as applicable, to record Assignee as the assignee and owner of the applicable Assigned Copyrights.

- 3. This Assignment Agreement is binding upon and inures to the benefit of the Parties hereto and their respective successors and assigns. This Assignment Agreement and the rights and obligations of the Parties hereunder shall be governed by, and construed in accordance with, the laws of the State of California.
- 4. Assignor agrees to execute and deliver such other documents and to take all such other actions which the Assignee, its successors and assigns may commercially reasonably request to effect the terms of this Assignment Agreement and to execute and deliver any and all affidavits, testimonies, declarations, oaths, samples, exhibits, specimens and other documentation as may be commercially reasonably required to effect the terms of this Assignment Agreement.
- 5. Any rule of construction to the effect that ambiguities are to be resolved against the drafting party will not be applied in the construction or interpretation of this Assignment Agreement. The words "include", "including" and variations thereof will be deemed to be followed by the words "without limitation". The use of "or" will not be deemed to be exclusive. This Assignment Agreement may be executed in counterparts, each of which when executed will be deemed to be an original but all of which taken together will constitute one and the same agreement. No modification or amendment to this Assignment Agreement shall be binding upon the Parties unless in writing and executed by the duly authorized representative of each of the Parties.
