**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (“**Release**”), dated as of July 5, 2022 is made by JPMorgan Chase Bank, N.A., in its capacity as administrative agent “**Administrative Agent**”), having an office at 2200 Ross Avenue, 9<sup>th</sup> Floor, Dallas, Texas 75201.

WHEREAS, Administrative Agent and Neenah, Inc., a Delaware corporation formerly known as Neenah Paper, Inc. (“**Grantor**”), are parties to that certain Amended and Restated Trademark Security Agreement dated December 18, 2014 and duly recorded on December 19, 2014 in the U.S. Patent and Trademark Office, Assignment Division, commencing at Reel No. 5422, Frame No. 0972 (the “**Security Agreement**”), whereby Grantor, as collateral security for the Secured Obligations, pledged and assigned to Administrative Agent, and granted to Administrative Agent, for the benefit of Administrative Agent and the Secured Parties, a continuing security interest in and to Trademarks (as that term is defined in the Security Agreement), together with, among other things, the goodwill of the business symbolized by and associated with the Trademarks and all applications and registrations thereof, and all proceeds thereof (collectively, the “**Collateral**”).

WHEREAS, Grantor has requested that Administrative Agent release its security interest in the Collateral and reassign any and all rights in the same to Grantor;

WHEREAS, Grantor has satisfied and fulfilled all of its obligations to release Administrative Agent’s security interest in the Collateral; and

WHEREAS, Administrative Agent now desires to release its security interest granted in the Security Agreement in the Collateral, including in those Trademarks identified and/or described in Exhibit “A” attached hereto (the “**Released Trademarks**”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent, without any representation, recourse, warranty or undertaking, hereby releases and discharges, all of its rights, title and interest in and to the Released Trademarks and, to the extent that the Security Agreement created a security interest in such Released Trademarks, Administrative Agent hereby releases such security interest in and any lien it held on such Released Trademarks. Administrative Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse, warranty or undertaking by Administrative Agent, any and all of Administrative Agent’s right, title and interest in and to the Released Trademarks.


