**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL**, dated as of July 8, 2022 (this "Release"), is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as administrative agent and collateral agent (in such capacity, the "Agent") in favor of DURATEC NEWCO, INC., a Delaware corporation (the "Grantor"). Capitalized terms used and not otherwise defined herein have the meanings given to them in the Security Agreement.

**WITNESSETH**

WHEREAS, Grantor, Agent, and the other parties party thereto from time to time, are parties to that certain Pledge and Security Agreement, dated as of November 2, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Grantor executed the Intellectual Property Security Agreement, dated as of November 22, 2021 (the "Agreement") and recorded with the U.S. Patent and Trademark Office on November 29, 2021 at Reel/Frame No. 7508/0338, pursuant to which Grantor pledged, collaterally assigned, mortgaged, transferred and granted to the Agent, its successors and permitted assigns, on behalf of and for the ratable benefit of the Secured Parties, a continuing security interest in all of Grantor's right, title and interest in, to and under the IP Collateral (as defined in the Agreement).

WHEREAS, Grantor has requested that Agent release its security interest in and to all of its right, title and interest in, to and under the IP Collateral.


NOW, THEREFORE, in consideration of the foregoing, Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the IP Collateral, including the trademark registrations set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the IP Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to Grantor, without recourse, representation or warranty, any and all right, title and interest that Agent may have obtained in, to and under the IP Collateral under the Security Agreement and the Agreement.
