**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS dated as of July 8, 2022, from **TMI TRUST COMPANY**, a Florida corporation, as collateral agent (together with any successor collateral agent or assign and any co-collateral agents, in such capacity, the “Collateral Agent”) in favor of The Money Store, L.P., doing business as The Money Box, a Texas limited partnership with principal offices at 3527 North Ridge Road, Wichita, Kansas 67205 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into a certain Trademark Security Agreement, dated as of July 30, 2021 (the “Trademark Security Agreement”), with the Collateral Agent, notice of which was recorded on July 30, 2021, at the United States Patent and Trademark Office at Reel 7442, Frame 0543;

WHEREAS, the Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent in and to all of its Marks, including without limitation those Marks listed in Schedule A. Grantor affirmed its intent to grant a Security Interest to the Agent specifically in certain Trademark Collateral;

WHEREAS, the Collateral Agent has agreed to terminate and release the Security Interest in all such Marks as herein provided.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Marks of the Grantor, including all of the goodwill of the businesses with which the Marks are associated, and assigns, transfers and conveys to the Grantor any interest in such intellectual property, including the Security Interest and any other liens. The Collateral Agent further hereby waives and relinquishes all of its rights, powers, privileges and remedies with respect to the Grantor and its successors and assigns in association with the Security Interest and hereby releases the Grantor and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.
