RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of July 7, 2022 (“Effective Date”) by DEUTSCHE BANK AG NEW YORK BRANCH, a duly licensed branch of Deutsche Bank AG, a banking corporation organized and existing under the laws of the Federal Republic of Germany, in its capacity as collateral agent (the “ABL Collateral Agent”), in favor of SHERIDAN HEALTHCARE, INC., a Delaware Corporation (“Grantor”).

WHEREAS, pursuant to the terms and conditions of that certain ABL NOTICE AND CONFIRMATION OF GRANT OF SECURITY INTEREST IN TRADEMARKS by and between Grantor and the ABL Collateral Agent dated December 30, 2016 (the “Trademark Security Agreement”; capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement), Grantor granted to the ABL Collateral Agent a continuing security interest in and to all of Grantor’s right, title and interest in and to all of the Trademarks (as defined in the ABL Collateral Agreement) owned by Grantor, including, without limitation, the United States trademark registrations set forth on Schedule A attached hereto (the “Trademark Collateral”);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (“PTO”) on January 3, 2017, at Reel 5957, Frame 0090;

WHEREAS, the Trademark Security Agreement has been terminated in accordance with the terms of the Credit Agreement and the ABL Collateral Agreement;

WHEREAS, the ABL Collateral Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the ABL Collateral Agent hereby terminates, cancels, and releases any and all security interests it has in or to the Trademark Collateral.


